To advance this vision, MQCI presents the AMTZ Medical Technology Awards, an annual initiative celebrating excellence, innovation, and best practices in medical technology.

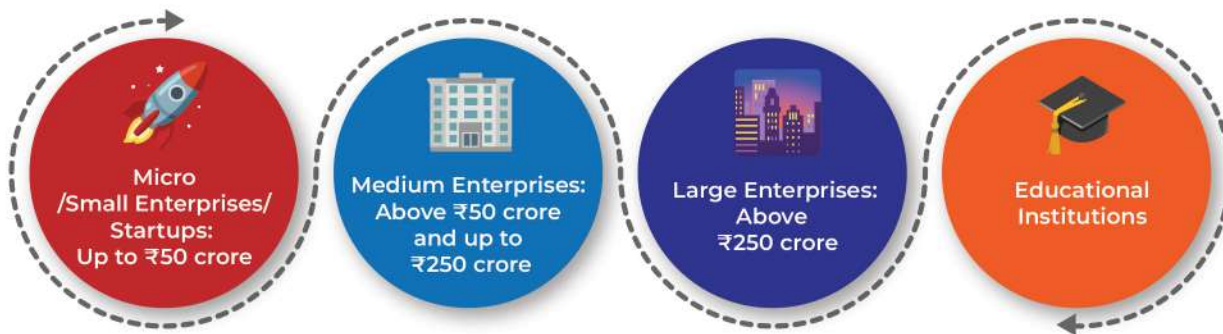

Eligibility Criteria:

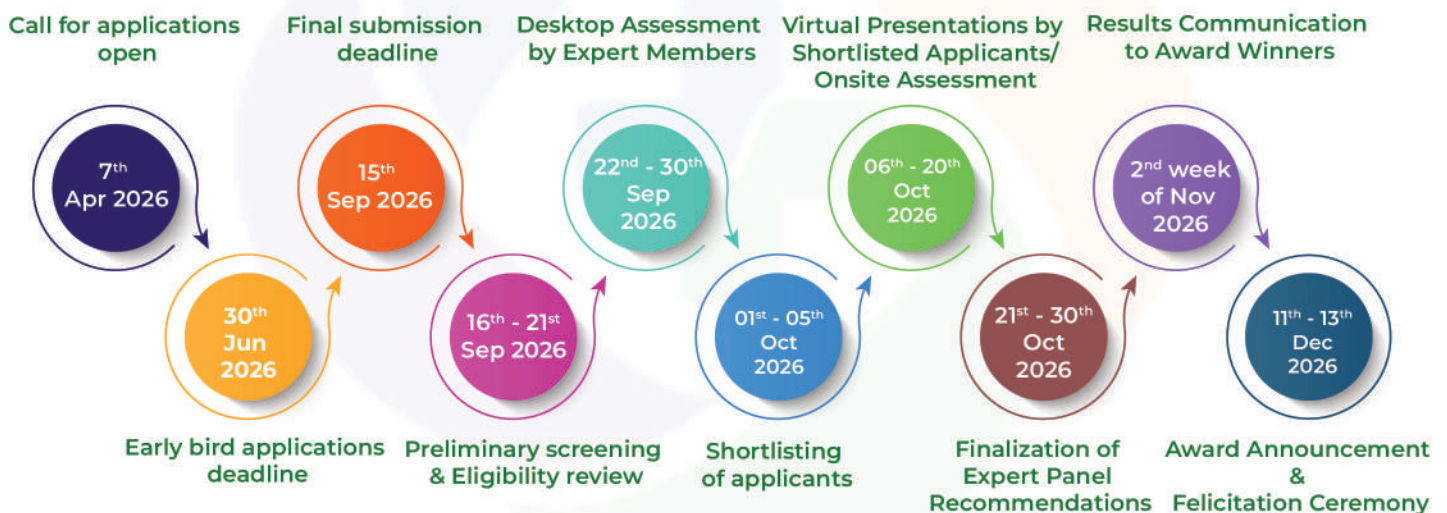
Organizations must meet the following conditions:

- **Legal Entity:** Must be a registered Indian organization operating in the medical devices sector (manufacturing or service support).
- **Experience:** Minimum 2 years of continuous operations in the relevant MedTech domain.
- **Performance Period:** Achievements and initiatives must be from the last two financial years.
- **Classification:** Must qualify under Micro/Small/Startups, Medium, or Large category based on latest audited annual turnover.
- **Application Limit:** Only one application per legal entity; subsidiaries may apply separately if registered and operating independently.
- Must be a recognized and affiliated educational institutions.
